## A. Enterprise Park Project Update

Mr. Smith informed the Board that he would be attending a pre-bid meeting on the 18<sup>th</sup> for the drain portion of the project, and that the Road Commission was finalizing the utilities plan. He reminded the Board that Northway Drive is a private road and would not be a part of the project. Mr. Smith also stated he is seeking legal opinion on

contract signing responsibilities, and that contracts will hopefully be ready for review in March. Mr. Kequom asked that a copy of plans be available for review at the Township Hall when available.

## **B.** General Projects Update

He will also discuss with the new property owners and bring the issue back to the next meeting for action.
