BACKGROUND INFORMATION

In February of 2018, the Economic Development Authority Board (EDA) approved a 2018/2019 Project List for both the East and West DDA districts. As part of this list the DDA Board approved improvements to several roads located within the EDDA district.

When the 2018/2019 project list was approved, cost estimates obtained by the ICRC indicated a total cost of \$127,342.97. Due to increases in materials and other factors, the attached contracts total \$160,801.77. A budget amendment in the amount of \$160,000 was approved by the EDA at the April 2018 meeting and was given final approval by the Board of Trustees at their April 25, 2018, meeting.

PROJECT FUNDING

The total funding for this project will be paid for by the EDDA.

PROJECT TIME TABLE

The Isabella County Road Commission approved the completion of these projects for the 2018 construction season contingent on their ability to complete them this year. Any of these projects that the contractors cannot get completed this year will not be held over into 2019. If the project is not completed the contract will lapse and need to be re-considered next year with updated pricing.
