A. Show Cause Hearing Location: 5116 Kay St / Owner: Richard Kerr / 14-064-00-004-00 / Violation regarding Section 8.4 Automobile or vehicle storage.

Township Planner stated that the property is zoned R-2B (One and Two Family, Medium Density Residential District. A complaint had been made and the Township Planner contacted the owner regarding outdoor storage of vehicles and trailers on a vacant residential property. This show cause hearing has been scheduled to allow the violator or his/her agent an opportunity to show why the provisions of the Ordinance should not be enforced.

^{*}Taylor Sheahan-Stahl arrived at 7:02 p.m.

Greg Lambert, 1019 S. University – Stated that for the past 15-18 years, Mr. Kerr has allowed him to use the property at 5116 Kay St. to store his vehicles, snowmobiles, campers, and trailers. He also stated that he maintains the property in return for the usage to store his working and plated vehicles.

Richard Kerr, 1019 S. University – Shared photos with the ZBA of the vehicles / trailers parked on the property stating that they are not junk / immobile vehicles & trailers. Closed 7:18 p.m.

Discussion by the ZBA Board.

Buckley moved **Sheahan-Stahl** supported recommending support of the complaint of outdoor storage of vehicles and trailers, finding the owner in violation and order that the violation be resolved in ninety (90) bringing the vacant property into compliance per section 8.4 of the current Zoning Ordinance. **Vote:** Ayes: 4 Nays 0.
