Ordinance No. 2012-02 Adopted: June 20, 2012

An Ordinance enacted pursuant to MCL 42.15, MCL 42.16 and MCL 41.181 to prohibit parking, standing, or stopping along Lincoln Road and along dead end streets connecting with Lincoln Road, within 200 feet of the center line of Lincoln Road, between Remus and Broomfield Roads.

THE CHARTER TOWNSHIP OF UNION, ISABELLA COUNTY, MICHIGAN, HEREBY ORDAINS:

#### 46.001 Title.

Sec. 1. This Ordinance shall be known and may be cited as the "Lincoln Road Bridge No Parking Ordinance". (Ord. No. 2012-02, § 1, 6-20-12 )

### 46.002. No Stopping, Standing or Parking.

Sec. 2. Stopping, standing or parking shall not be allowed within the road right of way along Lincoln Road and along the dead end streets connecting with Lincoln Road, within 200 feet of the center line of Lincoln Road, between Remus and Broomfield Roads. This section shall not apply to emergency situations or short duration vehicle breakdowns.

#### 46.003 Violations and Fines.

Sec. 3. A violation of this ordinance shall be subject to a fine of \$75.00. Each day a violation continues is a separate violation.

#### 46.004 Severability.

Sec. 4. If a court of competent jurisdiction declares any provision of this Ordinance invalid, in whole or in part, such declaration shall only affect the provision held to be unenforceable and shall not affect any other part or provision; provided that if a court of competent jurisdiction declares a penalty provision to exceed the authority of the Township, the penalty shall be construed as the maximum penalty that is determined by the court to be within the authority of the Township to impose.

## 46.005 Repeal of Conflicting Provisions and Effective Date.

Sec. 5. This ordinance shall take effect upon publication as required by law. All ordinances or parts of ordinances in conflict or inconsistent with the provisions of this ordinance are hereby repealed; provided that any violation charged before the effective date of this ordinance under an ordinance provision repealed by this ordinance shall continue under the ordinance provision then in effect.

## 46.006 Conditions Subsequent.

Sec. 6. This ordinance shall no longer be in effect if Lincoln Road is widened to four lanes between Remus and Broomfield Roads, or if the existing bridge within that area is replaced at any point in the future.
